Employee Benefits of Corporate Members: Frequently Asked Questions

Reusable membership cards: A limited number of reusable membership card(s) are issued to your company's corporate membership representative. Membership cards grant free admission for up to 6 visitors on each visit. Present the membership card in museum to get a 10% discount at Museum Store. In order to visit the museum, pick up a card from your company's representative and bring it to the museum. You do NOT need to present an employee ID at the front desk of the museum, but you must present the membership card. An employee ID may NOT be used in place of a membership card.

Personal Full-Price Membership Discount: A 10% discount on any full-price membership purchase (Individual, 2-Party, Dual, Family or Family Plus) is available to all corporate member employees. Use the custom code issued to your corporation to claim your discount. Check in with your corporate membership representative to get the code. Buy online or in paper application form.
